SUBJECT: NON-BINDING AGREEMENT OF INTENT WITH GDCD

Attached is a non-binding Agreement of Intent with Garrison Diversion Conservancy District (GDCD) to enter into a water service contract for sometime in the future to deliver water in the Sheyenne River to Fargo's intake facility in that river. The water will be brought from the Missouri River canal system into Lake Ashtabula reservoir and released when Fargo's current permitted water supplies are not available. The need for this non-binding Agreement of Intent is to allow GDCD staff to determine the quantity of water needed by water districts and communities in the 13 counties in eastern North Dakota that are members of the Lake Agassiz Water Authority and have joined together to implement the Red River Valley Water Supply Project (RRVWSP). Determining the quantity of water will allow the GDCD staff and consultants to begin planning and sizing the water treatment and delivery system to the Valley and to solidify the cost of the project.

At this time, the Agreement of Intent calls for a \$5,000 non-refundable deposit and a declaration of how much water Fargo intends to purchase. The Fargo staff and consultants have been involved with the RRVWSP since its inception and the projected water need for Fargo is 38 cubic feet per second which translates to about 25 million gallons a day. Our current average usage is about 9 million gallons a day in the winter months and 13 million gallons a day during the summer months. A feature of the RRVWSP, which is different from other state water projects such as the Southwest Water Authority sponsored project and the Northwest Area Water Supply project, is that those projects deliver treated water to each resident or business while the RRVWSP delivers raw water to Fargo's Sheyenne River intake. There are more treatment and delivery costs involved in delivering this water to our citizens once the water is taken from the Sheyenne. This is all background information for the question as to how much the RRVWSP will cost the Fargo taxpayers. It appears when this project is implemented, water rates can expect to increase from \$2 to \$5 a month per household for this raw water supply project. Staff is preparing a draft rate schedule for all of the water infrastructure needs, including the RRVWSP costs, for the next 25 years which will be presented to you in the very near future.



**AGREEMENT OF INTENT
TO ENTER INTO A WATER SERVICE CONTRACT
FOR A SUPPLEMENTAL WATER SUPPLY**

I. PARTIES

This non-binding Agreement of Intent is by and between the Garrison Diversion Conservancy District, PO Box 140, Carrington, North Dakota, 58421, hereinafter referred to as Garrison Diversion and _____, hereinafter referred to as the City/Water District.

II. PURPOSE OF AGREEMENT

The proposed supplemental water supply shall be referred to as the Red River Valley Water Supply Project, or RRVWSP. In order to develop sufficiently detailed and accurate preliminary designs for the RRVWSP, upon which further critical decisions concerning the RRVWSP can and will be based, it is necessary to identify as accurately as possible those cities and rural water districts which intend to contract for water from the RRVWSP. Therefore, the purpose of this Agreement of Intent is for Garrison Diversion to secure from the City/Water District a commitment of intent to contract for water from the RRVWSP in accordance with terms of this and subsequent agreements, for the reasons expressed in this section, and for the City/Water District to be assured that delivery of sufficient amounts of water to satisfy its projected needs to the area in which it is located will be included in the development of preliminary designs for the RRVWSP.

III. GENERAL TERMS OF AGREEMENT

1. The City/Water District hereby states its intent that it will enter into a water service contract with Garrison Diversion prior to June 30, 2010, based on a City/Water District nomination of _____ cfs for domestic needs and _____ cfs for industrial needs provided that the costs remain consistent with the EES Consulting Preliminary Cost Allocation Results Memo of May 1, 2008. Such water service contract shall be contingent upon approval of a satisfactory funding plan by the North Dakota Legislature for the RRVWSP in accordance and consistent with the terms and provisions of such water service contract. The water service contract will contain provisions concerning fees, the amount of water to be supplied, and other matters, all of which shall be consistent with the final recommendations of Garrison Diversion, in consultation with Lake Agassiz Water Authority, as part of the preliminary designs to be submitted on or before January 1, 2010.
2. Garrison Diversion agrees that the above nominated water needs of the City/Water District will be included in the development of preliminary designs for the RRVWSP.
3. Garrison Diversion further agrees to work with the Lake Agassiz Water Authority and its constituents to develop the previously described water service contract setting forth acceptable terms and conditions under which the City/Water District will be provided a supplemental water supply from the RRVWSP. The target date for presentation of a draft contract to their governing bodies is February 15, 2010.
4. This Agreement is a non-binding commitment of intent by the City/Water District to enter into a water service contract with Garrison Diversion to purchase a supplemental water supply from the

RRVWSP. This commitment is based on the City's/Water District's estimated share of capital costs as provided by the EES Consulting Preliminary Cost Allocation Results Memo of May 1, 2008, and the above nomination. The terms of this Agreement of Intent shall not be construed to establish the terms, fees, or conditions, under which the supplemental water supply shall be purchased pursuant to such water service contract.

IV. ESTIMATE OF COSTS

Based on 2005 costs, it is estimated that the operation and maintenance cost of the RRVWSP will be about \$4000 per cubic feet per second (cfs) of capacity per year pro rata contracted for in the water service contract. Preliminary estimates of the capital construction costs of the RRVWSP, based on 2005 costs, are approximately \$660 million. More accurate determination of capital construction costs and of operation and maintenance costs will be provided as part of the development of preliminary designs for the RRVWSP.

V. COMMITMENT FEE

The City/Water District agrees to pay to Garrison Diversion a non-refundable commitment fee of \$3500 per cfs of their projected supplemental water supply need pro rata for the City/Water District based on the above nomination, not to exceed \$5000. Payment of the commitment fee shall be forwarded to Garrison Diversion along with the executed copies of this Agreement of Intent. The fee shall be applied to Lake Agassiz Water Authority's share of preliminary design costs.

Mr. Thorson has purchased the building at 514 – 520 1st Avenue North and would like to locate the license at 518 1st Avenue North; however, the building will be remodeled and redeveloped so the license will not be used immediately.

Upon review of the submitted application I found that Hitesh Patel has ownership in the liquor license at the Quality Inn in Jamestown, ND. and Dickinson, ND. After contacting the Jamestown, ND. Police Department they informed me the bar at the Quality Inn did fail a compliance check on 09/16/05. I contacted Hitesh Patel and asked him about this incident. Mr. Patel stated they did fail the compliance check and as a result the employee and general manager were fired. I was unable to find any other information of concern related to either business.

The submitted application also indicates Anil Patel has a business interest in the Trappers Lounge In Minot, ND. I was unable to locate any information of concern related to this business.

Business Location

The application submitted is for a business currently located at 1340 21st Ave. South Fargo, ND. The immediate area surrounding this establishment consists of a mix of commercial, apartment properties and single family homes. I have found the following licensed liquor establishments in the immediate area, Peppers American Café, Bottle Barn Liquors, Happy Joe's Pizza and the Cajun Café.

Upon completion of this investigation I believe I have discovered all information related to the listed applicants and all information related to the issuance of the requested liquor license. - Class FARZ Authorizes the licensee to sell "on-sale" only; physical bar allowed. Required to be in the Renaissance Zone. No gaming and no "E" permits allowed. Requires 50% or more of its annual gross receipts from the sale of prepared meals and not alcoholic beverages. The initial fee is 1/2 of the FA license.
- Class FA-Golf On USGA Golf Course of 9 or more holes. Requires 25% receipts of food sales from April to October and 50% the rest of the year.

Upon speaking with Mr. Demar's about his 2005 Driving Under the Influence conviction he provided the following explanation. Mr. Demars stated he was going through a divorce at the time of the arrest causing him to drink to much, resulting in the arrest.

I also found a conviction for Disorderly Conduct dated June 7th 2005. I contacted the Becker County Sheriff's Department in Detroit Lakes, MN. and requested a copy of the report. Upon speaking with their records staff I was informed they were unable to locate the report in their records and were unable to locate a copy anywhere to include the court. They were able to inform me that a brief statement in the case file indicated a person was looking in a window.

Upon speaking with Mr. Demars about this incident he stated he was at his ex-wife's residence and began looking in her car when she contacted the police. Mr. Demars stated he was very upset about his wife being with another man at her residence. Mr. Demars stated he did strike her car at one point during this incident. Mr. Demars stated he was intoxicated at the time and was arrested by the police on this particular day.

I asked Mr. Demars about the 2006 Driving Under the Influence Arrest. Mr. Demars stated an individual from the public called into dispatch stating his vehicle was swerving. Upon review of the Cass County Sheriff's Department report I found that Mr. Demars was actually stopped by a West Fargo Police Department Officer; who then turned the investigation over to a Cass County Deputy for further investigation. Mr. Demars was arrested for Driving Under the Influence of Alcohol as a result of this investigation. Mr. Demars submitted to a chemical test indicating his reported alcohol content to be .16. This charge was eventually dismissed upon appeal due to the West Fargo Officer being outside his jurisdiction when the stop was made. Mr. Demars stated he was at a friend house and had a few drinks and did not feel he was under the influence when he left in his vehicle on this particular day.

Investigation notes

During my investigation I spoke to Paul Dzubnar and Michael Drummer about the other establishments they currently own. Both individuals indicated they have never had a liquor license suspended or revoked at any of their establishments. I was unable to find any violations at these establishments although Mr. Drummer indicated he believed they had failed a compliance check at the Lakeville, MN. business last year.

The application submitted is for a business currently located at 3340 13th Ave. South. The following establishments hold liquor licenses in this area; Juana's, West Acres Bowl, Cactus Jacks, Doublewood Lounge and the Acapulco Mexican Restaurant.

Upon review of the Fargo Police Records system relating to the Green Mill Restaurant I found two compliance check failures that occurred on the following dates, 03/22/04 and 08/28/07. Upon speaking with the current general manager Douglas Demars he indicated the employee's were fired as a result of the failure each time. Mr. Demars has been the general manager of the restaurant for the past four years.

Conclusion

Upon completion of this investigation I believe I have discovered all information related to the listed applicants and the proposed location. I have provided this completed background investigation to Fargo Police Chief Keith Ternes for his review and recommendation.





After conducting the required background investigation of the applicants listed on the attached alcohol beverage license application, I am recommending conditional approval of the application.

The investigation into the credit history of the two individuals listed or proposed by the applicant, Mr. Steven Lenthe, as being the on-site manager of the establishment causes me enough concern to initially recommend denial of the application. However, it is my understanding that the president/owner of Service Oil, Inc., Mr. Dirk Lenthe, plans on identifying a more suitable person to act as the on-site manager at a later date.

So as not to delay or preclude Mr. Lenthe from moving forward with his business plans, I'm recommending approval of the attached liquor license application, but only under the following conditions:

- Neither Candie Valadez or Todd Busche may act as the on-site manager, or be identified as having a specific interest in the liquor license.
- Mr. Lenthe must provide you with the name of a person who must be cleared through the required background investigation, and deemed suitable to act as the on-site manager of the establishment as determined by the Fargo Police Department; these stipulations must be met *prior* to the first day of serving alcoholic beverages.

In accordance with Section 25-1505 of the Fargo Municipal Code, I have conducted an investigation into the character, reputation, and fitness of the applicants listed on the supplied application.

Steven Lenthe and Candie Valadez were interviewed by telephone. During these interviews the applicants' criminal background, credit history, past residence history as well as any interaction they may have had with law enforcement in any state were questioned.

Upon completing these interviews and further follow-up investigation, I am disclosing the following information:

Upon speaking with Candie Valadez she said she has had some credit problems in her recent past. When asked about the cause of these negative credit entries Mrs. Valdez indicated she was doing a poor job of managing her finances and has since corrected these problems. Mrs. Valdez indicates she was unaware of the entry from MCI and she will be looking into the entry from the Halstad Telephone Company to get it resolved. When I asked Mrs. Valadez about her employment history with the applicant she stated she has been employed with the applicant for approximately four years and has been the general manager for three months.

09/04/2008 I spoke with Mr. Lenthe about the credit history of Candie Valadez . I informed Mr. Lenthe that the recent negative credit entries related to Candie Valdez were of concern to Chief Ternes and I. Mr. Lenthe indicated he would get back to me on 09/05/08 with a decision relating to Candie Valadez.

On 09/05/08 Mr. Lenthe contacted me and indicated that Candie Valadez would not be the manager of the establishment and that it would take him a few days to select a manager.

On 09/08/08 I received another name of Todd Busche who was identified as the proposed manager of the establishment. Upon preliminary investigation I found information that would lead me to believe that Mr. Busche would not be a suitable candidate for this position due to his recent credit history entries. I spoke with Mr. Lenthe about his information. Mr. Lenthe decided to remove Mr. Busche from the application after receiving this information. During this conversation Mr. Lenthe indicated he would be withdrawing the application and waiting until they have a suitable Manager selected.

On 09/09/08 I spoke with City Auditor Steve Sprague who indicated he had spoken with Mr. Lenthe about the application. Mr. Sprague stated he had spoken with Mr. Lenthe about the possibility of submitting the application without a manager being selected. Mr. Sprague stated he was comfortable with this, with the expectation being when a suitable manager is selected they would have to go through the background investigation process.

Investigation notes

After reviewing the liquor license application I found that Mr. Lenthe is currently the holder of a class (FA) liquor license at the Fargo Green Mill restaurant. Upon review of the Fargo Police records systems I was able to locate two compliance check failures at the Fargo Green Mill Restaurant. These failures occurred on 03/22/04 and 08/28/2007, each time the employee was fired as a result of the failure. Mr. Lenthe also listed a liquor license suspension that occurred in November of 2007 at the Green Mill Restaurant in Grand Forks, ND. This suspension was the result of a second compliance check failure at this establishment. At the time of this investigation the Grand Forks Police Department indicates they have no pending issues with this establishment.

The applicant indicated he holds liquor licenses in the following cities as well as Grand Forks. I checked the cities of Bismarck, ND. Mandan, ND. Glyndon, MN. and Bemidji, MN. I found one sale of alcohol to a minor charge that occurred on 11/03/08 at Stamart #15 located at 1120 East Divide Bismarck, ND. This case involved a clerk selling alcohol to a nineteen year old minor who was not conducting a compliance check. The clerk was fired as a result of this incident.

The establishment listed on this application currently holds a class (F) Alcoholic Beverage license that was issued in July 2003. I have found no information of concern related to this establishment and the class (F) alcoholic beverage license.

Business Location

The submitted application is for a location that is mostly industrial in nature with a limited amount of retail sales. The establishment is part of a large truck stop complex near the intersection of 12th Av. N and I-29. There are no other licensed liquor establishments within a several block radius of the proposed location of this establishment. Residential housing, consisting of a trailer park and single or double family homes are located several blocks to the east. There are also a limited number of multi-unit housing units in this neighborhood. This neighborhood area also has an elementary school and a couple of churches.

Conclusion

Upon completion of this investigation I believe I have discovered all information related to the listed applicants and all information related to the issuance of the requested liquor license. I have provided this completed background investigation to Fargo Police Chief Keith Ternes for his review and recommendation


