He said it would be better to either table an item or have the Commissioners present act than have a poor connection. He stated he would rather not call in but there are times that make it necessary to miss meetings because of work-related business.

Commissioner Williams said he understands the necessity to be gone and all of the Commissioners have used the conference call feature but the June 1, 2009 meeting conference call with two Commissioners did not go well. He suggested only one caller per meeting and also to notify Commission staff one week in advance of being gone. He said possibly calling in by telephone should not be allowed.

In response to a question from Commissioner Mahoney regarding a better microphone or call-in system, Executive Assistant Sharon Odegaard said she talked to Chief Information Officer Ron Gronneberg about the technology and he will look into available technology that may improve off-site communication.

Mayor Walaker said attendance should be required and call-ins should not be allowed.

Commissioner Williams moved the City Attorney be directed to draft an Ordinance eliminating the practice of remote calling for Commission meetings for consideration at the July 13, 2009 meeting and that Information Services staff be directed to look into alternative technology for conference calls.

Moratorium on On-Premise Signs Amended:

The Board received a communication from Senior Planner Jim Hinderaker stating on May 18, 2009, the City Commission approved a three-month moratorium on the issuance of all on-premise LED sign permit applications. At the direction of the Planning Commission, he said, staff is working to update the City of Fargo Sign Code. In an effort to address concerns raised by the sign industry, he said, staff suggests that some changes to the scope of the moratorium may be appropriate. In addition, he stated, staff suggests that to accurately describe the type of signage intended to be included within the moratorium, the language of the moratorium should be amended.

Mr. Hinderaker stated, since the moratorium adopted by the Board on May 18, 2009, the sign industry has expressed concern regarding the scope of the moratorium and there are a couple of options. The first option, he said, is to do nothing and let the moratorium stand as is and continue with updating the sign code. He said the second option is to reduce the scope by removing the moratorium on all on-premise signs that are greater than 300 feet from any residential zoned property and possibly include a Conditional Use Permit in the application process. He said 300 feet is defensible because it mirrors the off-premise Ordinance. The other option, he said, is to repeal the moratorium and direct staff to work with the various groups on the sign code. He stated the Planning Commission recommends removing the moratorium greater than 300 feet from any residential zoned property and replacing the term LED (Light-Emitting Diode) with EMC (Electronic Messaging Center).

Tom Neihart, 1102 9th Street South, said the Hawthorne neighborhood is a unique area and has been well maintained since the 1800s. He said the City has been involved with restoration and protection of historic neighborhoods and the Hawthorne neighborhood should not be used as a testing ground for LED signs. He said the issue presented tonight has to do with the LED signs and regulation of an updated sign code. Mr. Neihart submitted information from several studies in regard to the LED codes around the country and the need to update the sign code.

At 6:00 p.m. the Board took a five-minute recess.

After recess: All Commissioners present. Mayor Walaker presiding.

Linda Dregseth, 1205 7th Street South, said she is in support of the moratorium and the need to study the sign code.

David Schultz, Chair of the Historic Preservation Commission (HPC), submitted a letter on behalf of the HPC stating a motion was approved supporting the moratorium in relation to a Historic Overlay that was approved at their June 11, 2009 meeting. He said the HPC would welcome the opportunity to have representation as the sign code is reviewed and updated.

Bernie Dardis, Indigo Signworks, Inc., said he is in support of ending the moratorium. He said the City's sign code has been used as a benchmark for other cities' codes and now is not the time to rewrite it.

In response to a question from Mayor Walaker in regard to removing the moratorium on signs greater than 300 feet from residential zoned property, Mr. Dardis said 300 feet is used for billboards and the sign in question cannot be read from 300 feet, which is a full city block.

Jonathan Garaas, Attorney representing Steven Stremick, said Mr. Stremick received a Conditional Overlay with his application which was approved by the Board. Mr. Garaas submitted a sign application from Carl Ben Eielson School which was recently approved and which, he said, did not have to go through Engineering for a permit. He said Mr. Stremick is being singled out and he has tried to meet the objections raised by the neighborhood.

Commissioner Wimmer said signage does not belong in a historic area like Erskine's Addition. The sign code, he said, needs to be studied so that residential areas are protected from issues such as this. He suggested the moratorium be amended from 300 feet to 150 feet.

There was discussion regarding the use of radius or curb line for the standard of measurement in the moratorium. Planning Director Jim Gilmour said radius is used for sign-to-residential-property measurements and curb line is used for sign-to-sign standards. He said radius makes the most sense in this situation.

Commissioner Wimmer moved the moratorium on all on-premise LED signs that are greater than 150 feet from any residentially zoned property be removed and the term LED (Light-Emitting Diode) be replaced with EMC (Electronic Messaging Center).

Second by Piepkorn. On call of the roll Commissioners Wimmer, Piepkorn, Mahoney, Williams and Walaker voted aye.

No Commissioner being absent and none voting nay, the motion was declared carried.

First Reading of an Ordinance Annexing a Certain Parcel of Land Lying in the North Half of the East Half of the Northwest Quarter of Section 13, Township 138 North, Range 49 West, Cass County, North Dakota:

Planning Director Jim Gilmour said the request tonight is for annexation. He said the rezoning request will be on the July 13, 2009 agenda. Any questions regarding public safety, he said, could be directed to Chief Ternes.

Gene Kaseman, President of the Dakota Boys and Girls Ranch, said the organization and its facilities have always been good neighbors in the cities where they are located. He submitted documentation from the Ward County Tax Director regarding property value increases for properties near the Minot Dakota Boys and Girls Ranch. Mr. Kaseman said property values around the Minot campus went up an average of 7 percent in 2008 and an average of 8 percent in 2009.

In response to questions from Commissioner Williams regarding the cost to the City of providing services and flood protection plans for the property, Mr. Kaseman said annexation will bring necessary services to the area and the full value of the property can be realized through annexation. He said they have an agreement with the Planning Commission to build a containment pond which would benefit the entire area and a mass evacuation plan would also be in place if major flooding occurred. The organization, he said, wants to consolidate services in order to position itself for the next 15 to 20 years.

Commissioner Williams said the City should not subsidize the Boys and Girls Ranch facility.

At 7:05 p.m. the Board took a five-minute recess.

After recess: All Commissioners present. Mayor Walaker presiding.

Dave Ekman, 1615 Round Hill Drive, said he is opposed to the annexation. The Boys and Girls Ranch, he said, took a gamble when they purchased the property and the City has a growth plan which should be followed. Right now, he said, there is 3.5 square miles north of this property which should be annexed first.

In response to a comment from Dale Ziegler, 1630 Round Hill Drive, regarding Round Hill being in the Extraterritorial (ET) area and not having representation in the City, Mr. Gilmour said John Miller is the ET representative and more representatives are needed on the Planning Commission.

Jim Carlson, President of the Round Hill Association, said the neighborhood has serious concerns about the annexation of this property which includes the lack of tax revenue from a non-profit, flood protection problems and lack of services for the area.

Commissioner Piepkorn moved the requirement relating to receipt of the Ordinance by the Commission one week prior to first reading be waived and that the Ordinance Annexing a Certain Parcel of Land Lying in the North Half of the East Half of the Northwest Quarter of Section 13, Township 138 North, Range 49 West, Cass County, North Dakota be placed on first reading.

Second by Wimmer.

Commissioner Mahoney said with the new high school being built, it is important for this area to be annexed so infrastructure and services can be provided to the area.

Commissioner Wimmer said the City needs to be planning for the future and tonight's issue is the annexation proposal. He said there will be opportunity for discussion July 13th when the rezoning request is made.

Commissioner Williams said the annexation is a premature expansion and would be a detriment to the City.

On call of the roll Commissioners Piepkorn, Wimmer and Mahoney voted aye.

Commissioners Williams and Walaker voted nay.

The motion was declared carried.

Commissioner Wimmer moved that the Board adjourn to 5:00 o'clock p.m., Monday, June 29, 2009.

Second by Piepkorn. All the Commissioners voted aye and the motion was declared carried.

The time at adjournment was 7:35 o'clock p.m.
