**Recommendation to Proceed with a Request for Proposals for an Architectural Firm to Design a Fire Station in the Area of 45th Street and 40th Avenue South Approved:**

The Board received a communication from Fire Chief Bruce Hoover stating the City of Fargo budget for 2008 includes funds for architectural services for a new fire station in the area of 45th Street and 40th Avenue South to be constructed in 2009. He said the anticipated schedule for this project is as follows:

Advertise for proposals from architectural firms immediately.

The selection committee will review proposals, interview architects and have a firm selected by April 2008.

Design complete by fall of 2008.

Bid the project in late 2008 or early 2009 with an anticipated cost of 1.8 to 2 million dollars.

Completion of project and occupying the fire station by late fall 2009.

He said the members on the Review Committee for the project will be:

Pat Zavoral, City Administrator  
Kent Costin, Director of Finance  
Bruce Hoover, Fire Chief  
Dean Meyer, Assistant Fire Chief

Chief Hoover said \$100,000 was approved in the 2008 budget for this project. It is important, he said, to get the fixed numbers so they can figure what will be needed for next year's budget. He said Commissioner Wimmer has also agreed to be on the Review Committee.

Commissioner Wimmer moved the Request for Proposals for an architectural firm to design a fire station in the area of 45th Street and 40th Avenue South be approved.

**Appropriate Staff Directed to Draft an Ordinance to Address the Licensing of Contractors to Perform Repair, Rehabilitation or Re-Shingling of Residential Roofs Within the City of Fargo:**

The Board received a communication from Mayor Walaker stating the recent interest in the re-roofing of homes due to last summer's hailstorms coincided with staff

work on administering a program for contractors undertaking the work on roofs of homes and apartment buildings. He said after talking with staff, he suggested an amendment to the City building codes be adopted to address issues concerned with the re-roofing. He said a licensing process should be put in place whereby state licensed roof and general contractors purchase a local roofing license at an annual nominal fee from the City. These contractors, he said, would need to show evidence of a current state contractor's license, liability insurance and capability to secure a performance bond for work. He said the staff has surveyed surrounding communities in the tri-state area and the Sioux Falls, South Dakota model seems most appropriate for Fargo. City Planning and Codes staff, he said, have met with City Attorney Erik Johnson, City Administrator Pat Zavoral and himself and asked permission to bring forward a draft ordinance with provisions as stated.

Mayor Walaker said it is prudent to know who is working in the City and a licensing system will require that certain criteria are met by the contractors. He said new construction projects would not need licensing. It is impossible, he said, to inspect all roofing projects but at least the City would have a handle on who is doing the work.

Commissioner Williams moved the appropriate staff be directed to draft an Ordinance to address the licensing of contractors to perform repair, rehabilitation or re-shingling of residential roofs within the City of Fargo.

Second by Wimmer. On call of the roll Commissioners Williams, Wimmer, Mahoney, Coates and Walaker voted aye.
